- Each TBRU represents a contingent right to receive the value of one share of A. H. Belo Corporation Series A Common Stock. These TBRUs are valued as of the date of settlement and are paid 60% in shares of A. H. Belo Corporation Series A Common Stock and 40% in cash.
- The number of shares shown represents the settlement of the 40% cash portion of TBRUs that were settled and paid on May 14, 2015. Settlement of the cash portion is, pursuant to SEC guidance, deemed to be a sale of shares to the Company.
- These TBRUs were awarded on May 17, 2012.
- These TBRUs vested 100% on May 16, 2013 and were settled on May 14, 2015.
- These TBRUs vest 100% on the date of the Company's 2016 annual meeting of shareholders and are settled on or within 10 business days of the 2018 annual meeting of shareholders.
