- Each TBRUSU represents a contingent right to receive the value of one share of A. H. Belo Corporation Series A Common Stock. TBRUSUs are valued as of the date of vesting and are paid 60% in shares of A. H. Belo Corporation Series A Common Stock and 40% in cash.
- These TBRUSUs vest as follows: 40% on the third trading day following the annual earnings release date for the fiscal year ending December 31, 2016, 30% on the third trading day following the annual earnings release date for each of the fiscal years ending December 31, 2017 and 2018, respectively. Each tranche is settled within 10 business days after vesting.
